Forensic Nurse Examiner Training Course for the Adolescent/Adult Population

Description: This Maryland Board of Nursing approved course is a structured 42-hour didactic course to train the experienced RN to perform forensic examinations on patients age 13 years and older. Some components include self-paced learning modules that are completed outside of the classroom setting and required for course completion. There is a clinical skills component of 40 – 60 hours that must be completed in addition to the didactic coursework to submit for the Maryland FNE-A certification.

Forensic Nurse Examiner Clinical Skills Simulation Training Course
