



## THE RISE OF ONLINE SEXUAL EXPLOITATION OF CHILDREN

This training will review trends in child pornography, sextortion, sexual solicitation of minors and how child exploitation intersects with the healthcare system.

Joyce King is the Chief Counsel at the Frederick County State's Attorney's Office. She leads the Frederick County Cybercrimes Task Force, serves on the Maryland Internet Crimes Against Children Task Force, and is cross designated as a Special Assistant United States Attorney through the Department of Justice Project Safe Childhood. In addition to prosecution of child exploitation crimes, Joyce manages operations and communications for the State's Attorney's Office, provides legal counsel for multi-agency criminal justice policy initiatives and projects, and serves on the Legislative Committee for the Maryland State's Attorney Association. Joyce has assisted in expanding Maryland laws on child pornography, human trafficking, and domestic violence. Joyce is an alumna of George Washington University, American University: Women & Politics Institute, and the David A. Clarke School of Law.

Detective David DeWees is a Criminal Investigator with over 28 years of patrol & investigative law enforcement experience with both the Frederick Police Department & Frederick County Sheriff's Office. Detective DeWees is currently assigned to the Special Investigations Team with the Major Crimes Unit of the Frederick Police Department. Detective DeWees is assigned to various task forces combatting the sexual exploitation of children, to include the Frederick County Cyber Crimes Task Force, the Maryland Internet Crimes Against Children (ICAC) Task Force, and the FBI- Baltimore- Violent Crimes Against Children Taskforce. Detective DeWees holds a Bachelor of Science in Criminal Justice Administration.
